- 2. The expenditure shall be restricted to the approved amount mentioned in para 1 above.
- 3. The breakup of payment shall be as per approved DNIT.

- 4. The Time limit for completion of work shall be 15 (Fifteen) months excluding of 3 months
- . 5. No change of specification will be allowed to be done on the work by Chief Engineer/ Superintending Engineer/ Executive Engineer concerned at his own level, without the prior permission of Sub Committee constituted for this purpose.
 - 6. The work will be executed under the control of Engineer- in -charge and closely monitored by Project Development and Management Consultant (PDMC) of ULB under the AMRUT, IRMA, senior officer of MC Rewari and EE PHED Rewart.
 - 7. As per para no. 9b Guideline of JV under ITB of DNIT: The JV/Consortium agreement at the time of submission of Bid shall be allowed as unincorporated. In the event the bid of JV/Consortium is accepted and after the issuance of Letter of award (LOA), the IV/Consortium shall incorporate a new company under the Companies Act, 2013/1956. . In case, the bidder fails to observe/comply with this stipulation before the signing of contract agreement, the full Earnest Money Deposit shall be forfeited and other penal actions due shall be taken against all the members of the IV /Consortium, Which must be compiled with.
 - 8. All other term 8 conditions shall be as per approved DNIT and tender published including corrigendum will remain same.
 - 9. This letter is being issued after taking approval from the competent authority.

You are hereby instructed to start the above said work and execute an agreement with Municipal Council, Rewari within 15 days on non-judicial stamp paper of Rs. 100/-. By issuance of this work order your contract stands concluded and time limit shall be reckened from the date of 10 days after issue of this work order.
