I submit to state that, with reference to the letter 2nd cited, I am furnishing the following details for the short comings called for by the Principal Chief Conservator of Forests (HoD), Chennai.

- 1) As per the allowable width of right of way for laying 11kv transmission line is 7.00 meters, hence, the User Agency has reduced the width as 7.00 meter instead of 7.29 meter. Since, the reduction in the width for laying transmission line, the total area of the project required is reduced to 0.777 ha. The details has been uploaded by the User Agency in the online web portal - FORM - A of Part - I in "Additional information Details".
- 2) The User Agency has provided the details of beneficiaries for the project and uploaded in the online web portal - FORM - A of Part - I in "Additional information Details".

- 3) The legal status of the proposed survey numbers 1/1 of Sigaramanapalli village (proposed length of 164 meter) and 1/1 of Konganapalli village (Proposed length of 946 meter) has been declared as "Reserved Forest". The notification of Veppanapalli Reserved Forest is herewith enclosed in the online web portal – PART - II of "Additional information Details".
- 4) The User Agency has given undertaking that, the height of the transmission line will be laid more than 7-8 meter from the ground level. They also given undertaking for the other conditions provided in the recommendation letter of the Wildlife Warden.

 The same has been uploaded by the User Agency in the online web portal FORM A of Part I in "Additional information Details".
