A proposal has been received in this office on 17.06.2020 for diversion (under FCA-1980) of **11.8259 Ha.** of forest land for non-forestry purpose. The subject envisages the use of forest land for "Upgradation to 2 lane with paved shoulder/ 4 lane of Khajuwala - Poogal Section (Design chainage 0+000 to 30+812) and Poogal - Dantour - Jaggasar - Gokul - Goddu- Ranjitpura - Charanwala - Naukh - Bap section of NH-911 (Design chainage 1+430 to 182+725) (Total Length 212.107 Km) under Bharatmala Pariyojna in the state of Rajasthan on Hybrid Annuity Mode. **(Proposal No.: FP/RJ/ROAD/41036/2019).**

The site inspection of the land involved in the proposal has been done by me on dated 25.06.2020 on inspection of the site, it is found that land required by the user agency is a forest measuring **4.9453 Ha.**
