In Reference to the The Assistant Inspector General (Forest), Integrated Regional Office, Dehradun **letter No. 8B / HP / 01 / 18 / 2021 / FC/202, Dated 10.03.2021**, received from you through EDS, dated 18.03.2021, the point-wise reply of the observations is being submitted here with for your kind consideration.

**Reference: - Reference: -** In Reference to the Assistant Inspector General (Forest), Integrated Regional Office, Dehradun the point-wise reply of the observations is being submitted here with for your kind consideration.

- 1) Against column No. B2.3 we would like to inform your good self that the alignment of Thaltukhod Stage- II HEP falls in two Panchayats;
  - i) **Dhamchyan Panchayat**  
The project components such as Trench weir, Desilting Chamber, Approach Pipe line up to tunnel portal and also part of tunnel falls under Kharyan village and approach road to Power House along with some portion of the transmission line comes under the Cheling village area. Both these villages falls under the jurisdiction of Dhamchyan Panchayat.
  - ii) **Tarswan Panchayat**  
Mathibajgaan village falls under Tarswaan Pamchayat which is the last village of this Panchayat. After the boundry of this village ends, second Panchayat starts. The Tunnel, Edit of Tunnel, Forebay, Penstock, Power House, Switchyard and Tail race channel of Thaltukhod Stage- II project, all fall in Mathibajgaan village of Tarswan Panchayat.  
Therefore Kharyan, Mathibajgaan and Cheling villages are shown as beneficiary villages.
- 2) In the component wise break up the area of Dumping site IV, Dumping site V and the Bridge have been mentioned separately and uploaded in the additional information.
- 3) The name of whole surrounding area is Tikkan but the main Power House site of Thaltukhod Stage- II HEP falls under the jurisdiction of Mathibajgaan village only.
- 4) The area of Transmission Line in forest land and private land along with proper evacuation plan has been done and uploaded in the additional information. Four copies of the evacuation plan are attached for your reference and further necessary action.
- 5) This query needs to be attended at DFO level.

- 10) Complete PDF file of the case has been done and uploaded in the additional information.


