In continuation of uploading of the list of trees to be pruned for the said Forest Clearance proposal in On-Line "Parivesh Portal" on 05.06.2024, the remaining defect as communicated in the letter under ref.(3) cited is herewith rectified as detailed below.

In the statement showing the coordinates , the heading of the tables are kept as it is as "Left Inner" & "Left Exit" for the Left Side Segments i.e for Seg.1,Seg. 3 & Seg.5 and heading of the tables are corrected as "Right Inner" & "Right Exit" for the Right Side Segments i.e for Seg. 2, Seg. 4 & Seg. 6. The updated statements for all segments are also uploaded in the On-Line "Parivesh Portal".

Hence, it is requested that the Forest clearance for the subject work may please be expedited in order to overcome the Power crisis problem by evacuating 500 MW Power Generated from the ongoing Kundah Pumped Storage Hydro Electric Project apart from avoiding idle investment of about 1800 Crores which may cause loss to the Government as well as public and also to the protection of wild animals from old corroded transmission lines (since 1965) please.
