Subject: Accord of Administrative Approval for (Revised) Water Supply Scheme Wani Doursa Tekipora under JKIDFC Ltd.

ORDER NO: CE/PHE/ DB/ 170 OF 05/2020
DATED: 18 -05-2020

Administrative approval is hereby accorded for execution of Water Supply Scheme Wani Doursa Tekipora at a total cost of Rs.821.50 Lacs (Rupees Eight Hundred Twenty One Lacs and Fifty Thousand only) by debiting to following head of accounts:

(i) Expenditure under NRDWP/State Share /Capex : Rs.5.00 Lacs
(ii) Balance cost under JKIDFC : Rs.816.50 Lacs

The accord of administrative approval is subject to fulfillment of following conditions:-


- 1) That all BIS/IS codes and guidelines of CWC/CPWD are followed while formulating and implementing the project.
- 2) That all the items related to earthwork shall conform to authenticated NSLs.
- 3) That the NOC from Forest, Wildlife and R&B Department wherever required is obtained well before the commencement of works.
- 4) That any such items not covered under relevant schedule of rates shall be paid in accordance with the set codal procedures.
- 5) That the project drawing/layout plan/design is approved by the competent authority before/commencement of works.
- 6) That encumbrance free land duly authenticated by competent authority is available for the execution of project.
- 7) That there is no time or cost overrun involved in the project and set time line in respect of scheme is strictly adhered to.
- 8) Sustainability of source and quality of water shall be rechecked by Executive Engineer/ Superintending Engineer before execution of works.
- 9) Executive Engineer will ensure that old languishing systems are made functional and merged with the proposed scheme.
- 10) That the villages/habitations proposed under the schemes do not figure within the scope of any other ongoing scheme/project.
- 11) That the discharge available is adequate and will cater the need of the population for the entire designed period proposed to be covered under the scheme.
- 12) That the proposed scheme will in no way have any adverse impact on other existing scheme.

- 13) That e-tendering mode is followed for finalization of awards and working DPRs are followed in the advertised BOQ.
- 14) That the expenditure incurred on the scheme is restricted to the Budget provision from year to year and within the accorded amount of AAs.
- 15) That the works covered by this approval are allotted on most reasonable rates after completion of all the codal procedure requirements.
- 16) That the funds earmarked for the project shall not be diverted or parked in deposit just to avoid lapsing of funds.
- 17) That the geo-technical investigations are conducted wherever required.
- 18) That the officers of CGW/expert agencies shall have to be coopted for ascertaining committed availability of water in the aquifer before attempting exploration of tube well.
- 19) That technical sanction with respect to design specification is accorded by the competent authority after accord of Administrative Approval.
- 20) That the existing distribution network wherever rendered redundant is optimally retrieved and accounted for.
- 21) The Superintending Engineer/Executive Engineer shall ensure that the scheme qualifies to be taken under languishing programme to be funded under JKIDFC.
- 22) That before commencement of work/making of payments thereof the Superintending Engineer/Executive Engineer shall ensure to submit component wise physical and financial statement in respect of a specific programme. Under which the schemes were taken up prior to its languishing status, discussing in detail the component-wise/item-wise reasons of excess over the original cost of scheme.
- 23) That all the norms and guidelines as prescribed under the languishing programme (JKIDFC Ltd. funding scheme) shall be adhered to in letter and spirit and no deviations whatsoever are made.
- 24) That the project shall be subject to mid-term appraisal during execution by a third party/as per the guidelines of the programme and declared completed/ commissioned after trail run and performance evaluation for at least one season.

The technical vetting of the project is exclusively for the purpose of Accord of Administrative Approval and shall neither be construed as any rate approval nor technical sanction to the project or any approval for inclusion in the Plan.
