

As per your memo under reference the said land is in possession of MC Dharamshala since April 1996 where as the reply submitted by the user agency and certificate issued by the user agency the said land is in possession prior 1980.	This reply the possession has not been mentioned since 1996 but use of the land has been mentioned since April 1996 because possession over this land of MC Dharamshala is prior 1980. The record of possession related activities till 1996 has already been submitted in this reply and now the record of possession over this proposed land prior to 1980 is being submitted here in which the copy of the proceeding of general house then the Municipal Council, Certificate regarding possession and GPS tagged Photographs has been enclosed.

So therefore you are requested to kindly consider the proposal for further process and approval in favor of Solid waste management Plant Dharamshala.

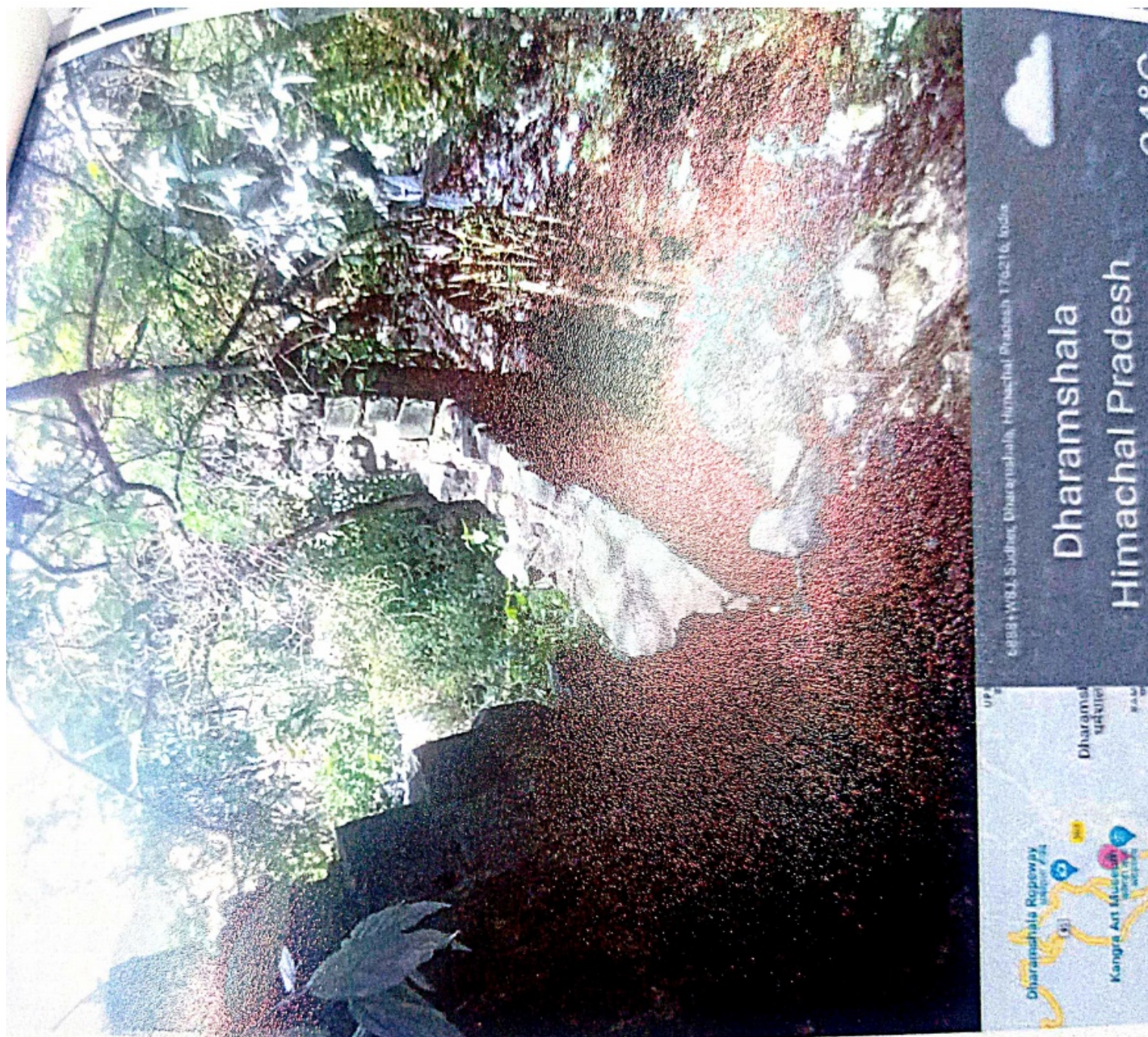
