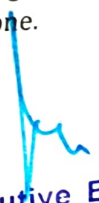

3. There are no rare/ endangered/ unique species of flora and fauna found in the area. If so, the details thereof. **No**

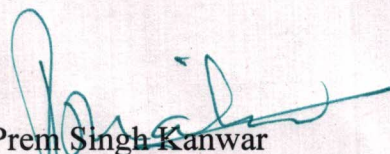

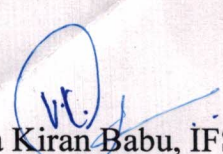
