(b)	2	The main purpose of proposed road is to Vill Karoli to Bana Enclave connect and vill Karoli to Khetarpal Enclave. The projected road will be specifically used for defence purpose such as movement heavy loaded vehs which requires broader roads.	
(c)	3	Temporary employment is 20 instead of 0 and permanent employment is also 20 instead of 0. The same has to be uploaded online correctly by DFO, Pathankot.	
(d)	4	The name of misc species trees has been uploaded online by DFO, Pathankot.	
(e)	5	Different linear plants has been correctly uploaded online for different area requirement.	
(f)	6	Nomenclature of work is the same which is uploaded online i.e. provn of internal rds connecting Mamun Mil Stn to Ajeya Grn (PH-II). Hence, there is no change in nomenclature of works. The widening of road from Karoli to Bana Enclave and Karoli to Khetarpal Enclave is part of the main proj.	
(g)	7	The NOC certificate from the land owing agencies is forwarded to DFO, Pathankot.
