In compliance of the Ministry of Environment and Forest (MoEF). Government of India's letter No. 11-9/98-FC(pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **3.570 Ha. Forest Land & 0.473 Ha. of Revenue forest land, Total Area 4.043 Hectare land** proposed to be diverted in favour of **CEO, Chhattisgarh Infotech Promotion Society (CHIPS) Raipur, C.G. for laying Optical Fiber Cable in BharatNet Project** work in Korba district falls within jurisdiction of *Bhaishma, Chachiya, Kudmura* village in korba tehsils and *Charmar, Madwani, Nondarha, Rampur, Botali, Tenganmar, Kartala, Kotmer, Nonbira, Dongaama, kanki, Supatarai, Chiknipali, Aurai, Kervaduvari, Sendripali, Kalgamar, Labed, Sandel, Kathrimal, Rewabahar, Badmar, Suaara, Barpali, Beharchuwa, Koi, Nawapara* village in *Kartala* Tehsils.

It is further certified that :

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for **3.570 Ha. Forest Land & 0.473 Ha. of Revenue forest land, Total 4.043 Hectare land area** proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committees and the District level Committee are enclosed .
- (b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (c) The proposal does not involve recognized right of Primitive Tribal Groups and Pre-agricultural communities.
