महोदय.

Please refer your letter dated 28.12.2021 vide which proposal seeking NOC case for Construction of approach road for proposed fuel station of M/s Indian Oil Corporation Limited on Charkhi Dadri to Loharu Section of NH-334B at Km. 191.932 (LHS) at Village Barsana, Tehsil & District Charkhi Dadri in the State of Haryana was submitted for provisional approval.

The said proposal was verified and was recommended to RO Chandigarh. After verification of the same the provisional approval on the same has been accorded by Highway Administration (HA) cum Regional Office NHAI Chandigarh at Panchkula vide letter dated 15.06.2022. The above provisional approval is subject to the fulfillment of conditions mentioned in License Deed and MoRT&H Circular dated 26.06.2020 & its subsequent amendment.

Further, it is intimated that, Development of National Highways is a continuous process and therefore, the permission granted is temporary in nature. The provisional access permission granted is without prejudice to Government to acquire applicant's land (plot of private property), if required for future development of National Highways.

Notwithstanding to the above, the provisional NOC issue shall stand to be cancelled under the following circumstances-

- i) If any document/information furnished by the applicant proves to be false or if the applicant is found to have willfully suppressed any information.
- ii) Any breach of the condition imposed by the Highway Administration or the officer authorized by the Administration on his behalf.

- iii) If at any stage, any dispute arises in respect of the ownership of the land on which the retail outlet is located or regarding the permission for change of land use.
- iv) The provisional permission should not be used for any other purpose including for changing the land use pattern.
- v) Further, it is intimated that in case the access construction is not completed within stipulated time period, this office may encash, the BG no E33GT02221460002 dated 26.05.2022 which is valid upto 25.05.2025, immediately.

The compliance related to construction along with the requisite documents to be submitted to this office after completion within the stipulated time. Please note that access to the fuel station should not be made operational before issuance of final permission including signing of license deed and construction of other facilities and drainage structures related to the fuel station as per the approved drawing. It is also requested that the applicant will keep close coordination with IE of the project while constructing proposed service road as per approved drawing.

The in-principal approval of the Competent Authority is hereby conveyed for further necessary action please.

Based on recommendation made vide your letter cited above, the provisional approval of Competent Authority for access permission to the proposed retail outlet of M/s IOCL on Charkhi Dadri to Loharu Section of NH-334B at Km. 191.932 (LHS), subject to the fulfillment of conditions mentioned in License deed and MoRT&H circular dated 26.06.2020.

- 2. Further, development of National Highways is a continuous process and therefore the permission granted hereby for use of NH land doesn't restrict the development of NHs. Thus, the permission being granted hereby is temporary in nature. The provisional access permission granted hereby is without prejudice to Government to acquire applicant's land (plot of private property), if required for future development of National Highways.
- 3. Notwithstanding to the above, the provisional approval shall stand cancelled under the following circumstances:
- (i) If any document/information furnished by the applicant proves to be false or if the applicant is found to have willfully suppressed any information.
- (ii) Any breach of the condition imposed by the Highway Administration or the officer authorized by the Administration on his behalf.
- (iii) If at any later stage, any dispute arises in respect of the ownership of the land on which the retail, outlet is located or regarding the permission for change of land use. The receipt of approved layout plan may kindly be acknowledged.
- 4. Apart from the above, following is directed:
- (i) In case the access construction is not completed within stipulated time period, then PD Bhwani on behalf of this office encash BG of Rs. 2,75,625/- bearing no. E33GT02221460002 dated 26.05,2022 is valid till 25.05.2025 immediately and also ensure that BG shall be in name of PD Bhwani
- (ii) Before conveying in-principle approval PD-Bhwani may verify amounting to Rs. 20,000/-towards processing fee for subject retail outlet has been deposited in "Bharat Kosh" under Transaction ref. no. 2605220031719 dated 26.05.2022
- 5. The given provisional permission for access should not be used for any other purpose including for changing the land use pattern.
