Kaksh/survey/3933 dated 28/02/2013 wherein as per Forest Conservation Act 1980 proposal is not submitted for 229.0 hectare i.e. 38.58 hectare land is shown as non forest land which is also part of Manikgarh reserve forest range (190.42+38.58=229.0) hence proposal to be submitted for 229.0 hectare.	The Initial Mining lease executed by M/s Manikgarh Cement with District Collector Chandrapur on 17/08/1981 for 643 hectare area for mining of limestone out of which an area of 150.62 hectare is surrendered by Manikgarh Cement being the non mineralized area on dated 27/08/1987 the balance area remain 493.0 hectare including of 429.38 hectare forest land and 63.62 hectare Revenue/Patta land out of which an area of 264 .0 hectare was cleared by MoEF Govt. of India on dated 04/02/1986 for mining of limestone inclusive of 238.96 hectare forest land and 25.04 hectare of Revenue /Patta land at the time of renewal of Mining lease the Govt. of Maharashtra renewed the mining lease for 302.58 hectare i.e. 238.96hectare forest land (Forestry renewal is granted vide letter no.F.No.8-64/2001-FC Dated28.11.2001)a and 63.62 hectare Revenue/Patta land vide their letter no. MMN-2201/150/Ind-9,15/11/2002 and accordingly mining lease is also executed for 302.58 hectare on dated 12.05.2003, through this order the State Govt. also advise us to get necessary clearance in respect of 190.42 hectare area accordingly MoEF has also given Environment clearance for aforesaid 190.42 hectare area for mining of Limestone vide letter no. J-11015/387/2006-IA.II (M) dated 24.10.2007. On dated 03/06/2016 vide letter no. MLV-C-329/II/2016/1478 Dated-03/06/2016 again advises us to get forestry clearance for aforesaid 190.42 hectare forest land so that balance part of mining lease shall also be executed. In view of the above clarification we would like to submit that both surface and mining right in respect of the 38.58 hectare is available with the company and hence this proposal is submitted only for 190.42 hectare Forest area.

		Mining Plan for existing Mining lease of 302.58 (238.96 hectare forest land+ 63.62 hectare Revenue/Patta land inclusive of 38.58 hectare Revenue/Patta land) is already approved by IBM. Mining plan for proposed Diversion land of 190.42 hectare is also approved by IBM. Hence this proposal is submitted for 190.42 hectare of forest land However fresh enumeration of trees have been done both for 190.42 hectare forest land and 38.58 hectare revenue /Patta land as in accordance with the forest guide line point 4.4 no mining work is initiated in this area since 1981 because of that some trees have grown in this land. The company is ready to bear the cost of deforestation in the aforesaid area of 38.58 hectare. . (Copy of all references is attached along with covering letter for kind perusal and clarification).
