- You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
- Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 06/05/2027 to the Board.
- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

1. The CTE is valid for the installation of M/s RETAIL OUTLET DEALERSHIP MS/HSD, LOCATION ON NH-25 FROM NAWABGANJ TOLL PLAZA TO UNNAO-LUCKNOW BORDER ON LHS, GATA NO.-489, 490, VILL-KUSHAHRI, PARGANA-GOVIND PARSADAN, TEHSIL-HASANGANJ, DISTRICT-UNNAO for the Storage and Distribution of H.S D.- 20 KLD and M.S. PETROL- 20 KLD.
2. Domestic effluent (1.0 KLD) shall be discharge through septic tank/soak pit.
3. No any industrial effluent shall be discharged to outside of the factory premises/drain/land and unit shall make proper arrangement for achieving zero liquid effluent discharge.
4. According to proposal, DG set (1×25 KVA) shall be be equipped with acoustic enclosure and adequate air pollution control devices. The emissions/noise level must be conformed to the prescribed standards of Environment (Protection) act 1986 (as amended).
5. The unit shall not consume any fuel except authorized/consented without the prior written permission of the Board.
6. The unit shall take adequate measures for control of noise under the Noise Pollution (Regulation and Control) Rule 2000, from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75 dB(A) during day time and 70 dB(A).
7. The unit shall provide adequate arrangements for fighting the accidental leakages/ discharge of any air pollutant/gas/liquids fuels from the vessels, mechanical equipment etc. which are likely to cause environmental pollution.
8. The adequacy and efficiency of the air pollution control devices will be the entire responsibility of the unit.
9. Unit shall make proper arrangement for disposal of the hazardous waste through authorized recyclers/TSDF.
10. Plant machinery will be installed as mention in submitted industrial project report.
11. Unit shall develop green belt by miyawaki method as per the Protocol attached with Board's office order H 16405/220/2018/02 dated 16-2-2018, which is available on Board's website www.uppcb.in.
12. Disaster Management Plan as per guide line of Factory Department must be installed.
13. Proper Safety Devices must be provided to the workers.
14. All the effective safety measures must be taken to avoid any contamination/deterioration in the surrounding environments/ecosystem.
15. The provisions/guidelines notified under the Environment (Protection) act 1986 (as amended) must be strictly complied.
16. Proposal for Rain Water Harvesting System must be submitted this office within two month.
17. Unit shall abstract ground water with the valid permission (N.O.C) of competent Authority (State Ground Water Authority).
18. NOC/ license/Consent of concerned departments for installation & operation of unit must be obtained and submitted this office within two months.
19. Housekeeping of the unit should be maintained properly.
20. Application for water and air consent must be applied before two month of expected trial production. Trial production must be started after obtaining the valid consent from the Board.
21. Establishment of plant & machinery must be strictly done as per submitted proposal.
22. It is mandatory to submit compliance/progress report monthly in reference to all condition of the CTE.
23. This CTE is issued as per the provisions of Environmental Acts. NOC/ license/ Consent/ approval of all other concerned department for installation of unit, as per the statutory provisions, must be obtained.
24. This CTE order will not affect the acceptance or order of any other department.
25. Knowingly making any false statement for obtaining CTE or compliance of the conditions shall result in the imposition of criminal penalties as provided under the section 42(g) of the Water Act or section 38 (g) of the Air Act.
26. The applicant shall allow the officials of Uttar Pradesh Pollution Control Board and/or their authorized representative, upon the representation of credentials:
 - a. To inspect raw material stock, manufacturing processes, reactors, premises etc to perform the functions of the Board.
 - b. To enter upon the applicant's premises where an effluent source is located or in which any records are required to be kept under the terms and conditions of this consent.
 - c. To have access at reasonable times to any records required to be kept under the terms and conditions of this CTE.
27. This CTE is transferable, in case of change of ownership/management and addresses of new Owner/ partner/directors/proprietor should immediately apply for the same.
28. The issuance of this CTE does not convey any property rights in either real or personal property or any exclusive privileges, nor does it authorize any invasion of personal rights nor any

infringement of Central, State or local laws or regulations.

29. The applicant shall submit such information, forms and fees as required by the board not later than 180 day prior to the date of expiration of this CTE.

30. Unit shall provide safety measures such as Helmets, Gumboots, Goggles, Masks etc. to the workers for their safety.

31. This CTE order is being issued with the intention that no pollution or land ownership dispute is pending and no such litigation is pending in any court, otherwise the consent order will be deemed to be nullified.

32. Unit shall abide by directions given by Hon'ble Supreme Court, High Court, National Green Tribunals, Central Pollution Control Board and Uttar Pradesh Pollution Control Board for protection and safeguard of environment from time to time.

33. The unit shall comply the notifications issued under the Environment (Protection) Act, 1986 from time to time.

34. Nothing in this N.O.C. shall be deemed to neither preclude the institution of any legal action nor relieve the applicant from any responsibilities or penalties to which the applicant is or may be subjected under the provisions of the Water/Air Acts respectively.

35. All amendments/revisions made by the Board in the emission/stack height standards shall be applicable to the unit from the date of such amendments/revisions.

36. The Proposed unit shall submit a Bank Guarantee of Rs. 10,000/- within 15 days for complying the above conditions.

Please note that consent to Establish will be revoked, in case of, non compliance of any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 09/06/2022 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
