This road starts at Km.0/0 at Sirikonda Mandal head quarters, which is identified as one of the high density traffic corridor under MDR and ends at Vemulawada, having a total length of 20.50 kms. The entire road is having Black topped surface. As per the road statistics the total length of the road is 20.50 Kms.i.e, Single Lane from Km.0/0 to 20/5.</p> <p>The existing road is passing through forest area in different stretch's as mentioned against item no. 2 below.</p> <p>As per the area statement enclosed, 4.971 Hactors or (12.283Acres) of forest land is required for diversion.</p>




