ORDER:

The Hon'ble Chief Minister on the floor of the Tamil Nadu Legislative Assembly during the Public Works Department Demand on 28.6.2017 has announced that the work of Formation of a Tank across Jungle stream near Kanakkampalayam village in Gobi Taluk of Erode District would be taken up at an estimated amount of Rs.65.53 Crore.

2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department, Chennai in his letter first read above has sent an estimate for the above work at an estimated cost of Rs.64.75 Crore. The scheme envisages the following:-

(a) Kanakkampalayam tank is situated in Kanakkampalayam village of Gobi Taluk in Erode District, just at about 5 Km of Bungalow pudur-Kallipati road and as the Kalipatti firka in Gobi Taluk

of Erode District in which this tank scheme is located in a very backward area, development is needed. Since the irrigable lands in this area mainly depending on rain, dry crops are proposed for irrigation in this Kanakkampalayam area and in order to overcome the water crisis, the Kanakkampalayam village people requested for formation of a tank across jungle stream to provide irrigation facilities for the dry lands lying on both sides of the odai in Kanakkampalayam village limit.

(b) This jungle stream takes its origin near Madapatti hill village, about 11 km from the Kanakkampalayam village in the midst of Gudiyalathur reserve forest and flows southern direction for about 13.5 Km and falls into Bhavani river and the flow is available during both South west and North east monsoon and there are no existing works across the stream either upstream or downstream of the proposed tank site.

(c) In addition to direct irrigation, 1800 acres of cultivable land will be indirectly benefited through recharging the wells in Kanakkampalayam, Perumugai and Kondayampalayam village and 492 openwells and borewells will be benefited by implementation of the scheme.

(d) The main components of the estimate are

1. Formation of Tanks.
2. Forming an earth bund 1250m length including uncontrolled spillway.
3. Construction of two tower head sluices.
4. Excavation of right side canal and left side canal.

(e) The cost of estimated works is Rs. 64.75 Crore based on the schedule of rate for the year 2017-18 and the B.C ratio for the above scheme works out to 1.09:1 and rate per hectare to Rs. 6,95,600/-.

3. The Chief Engineer, Plan Formulation, Water Resources Department has, therefore, requested administrative sanction for the above scheme at an estimated cost of Rs.64.75 crore under NABARD loan assistance.

4. In the Government letter second read above, the proposal of the Chief Engineer, Plan Formulation, Water Resources Department was forwarded to NABARD at an estimated cost of Rs 64.20 Crore (Excluding the L.S.Provision for Audit & Accounts and restricting LS Provision for Advertisement charges to Rs.10.00 lakh) for sanction of loan assistance under RIDF XXIII for the year 2017-2018. The Deputy General Manager, NABARD in his letter third read above has conveyed the sanction for the above work.

5. The Government after careful examination accord administrative sanction towards formation of a tank across jungle stream near Kanakkampalayam village in Gobi Taluk of Erode District at an estimated cost of Rs.64.20 Crore (Rupees Sixty four Crore and Twenty lakh only) with NABARD loan assistance under RIDF XXIII for the year 2017-2018 .

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account

"4702 - 00 Capital Outlay on Medium Irrigation - 101 Surface Water - State's Expenditure - JU Formation of Tank across Kattu Odai in Kanakkam Palayam village, Gobichettipalayam Taluk, Erode District with NABARD loan". (DPC:4702-00-101 JU -1607)

7. Necessary funds have been provided in Budget Estimate, 2018-2019. The Engineer-in-Chief, Water Resources Department Public Works Department, Chennai is directed to incur the above expenditure in Budget Estimate 2018-2019, after the Appropriation Act is passed in the Legislature.
