

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the forest land to be diverted under FCA)

A Proposal has received by this office from Reliance Jio Infocomm Ltd. on dated 04/12/2021 for diversion under (FCA-1980) of 0.5924 Ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of laying of Optical Fiber Cable (OFC) along with road from SH-101 (Palia-Trikulia-Khajuria Road) from Km. 82.20 to Km. 119.50, NH-730 (Pilibhit-Betia-Assam Road) from Km. 88.00 to Km. 92.50 & SH-21 (Bilraya-Panwari Road) from Km 1.50 to Km 8.60 and from Km. 18.70 to Km. 26.00. Total Km. 56.20 & 0.5924 Ha. in North Kheri Forest Division, District Lakimpur Kheri-UP. The site inspection of the land involved in the proposal has done by me on dated 04/01/2022

On inspection of the site, it is found that the land required by the user agency is a RF / Un-Classed / Protect forest measuring of 0.5924 Ha
