



Detailed Note on the Project

The Panchayat Raj Department, Govt. of A.P., Kurnool, Kurnool district has taken up the formation and development of single lane road with shoulders under Krishnapushkaralu 2016. The existing road is cart track from Kapileswaram to Sangameswaram in which 2.03Ha area is lying in the reserve forest. Now it needs formation of road to top width of 10 m and thus involves protruding into the reserve forest.
