No.898. The total forest land is to be required $0.15 \text{ ha.} (425 \text{ mtr } \times 3.5 \text{ mtr} = 1487.50 \text{ Sq.m.})$

The forest area demanded is the barest minimum and immediate requirement for the proposed 22KV, 400mm H.T.Cable electric line project. There is no alternative non forest land available for this purpose. With the supply of electric line, problem being solved by laying this line for our company it will be indirectly help the company production also help increase the level of business in our company which will speed up our annual income. Hence it would help to achieve the National Productivity also. All possible alternatives were examined by us but there is no alternative non forest land available for this purpose. It is not possible to avoid the forest land. It is unavoidable.

We learn from the forest department that the required land is Reserve Forest land. However, the prior permission of the Government of India, under the provision of the Forest (Conservation) Act 1980, is necessary & essential for carrying any non-forestry work in such forest land. We are aware of the fact, that such forest land have comes under purview of the provisions of the Forest (Conservation) Act 1980, making it

incumbent on the State Government to obtain prior approval of the central Government under the provision of the said Act. Hence submitted this proposal for approval.

IV) Justification for locating the The propose electric line supply pole is in Forest Comptt No. 303 Gut No.675 & the boundary of constructed industrial zone area and near 425 mtr from our Hirschvogel Components India Pvt. Ltd. company. In above company there are average employing is 1300 to 1350 per day & their livelihood depend on this industrial work. With the supply of electric line, problem being solved by laying this line for our company it will be indirectly help the company production also help increase the level of business in our company which will speed up our annual income. Hence it would help to achieve the National Productivity also. There is no option to construct laying underground electric line South side of parallel boundary of Forest Comptt No. 303 Gut No.675 is totally built-up & covered by various factories. There is no scope to remove

the permanent structure of other factories to construct the laying underground electric line because the factories are manufacturing different type products. Therefore is no any other alternative non forest land is available for propose line. We have examined all other possible alternatives, but it is not possible to avoid the forest land. The demanded area is open forest. The require forest area of this purpose is only 0.15 ha. The required land is Reserve Forest land. However, the prior permission of the Government of India, under the provision of the Forest (Conservation) Act 1980, is necessary & essential for carrying any non-forestry work in such forest land.
