I submit to inform that M/s Total Environment Habitat P Ltd, No4/41, Tuneri main road GCP Doddabetta Ooty, Nilgiris District has submitted online forest clearance proposal under section-2 of Forest (Conservation) Act, 1980 for diversion of 0.36 ha of forest land for approach road to patta fields for Resort construction in Udhagai Rural Extension-I Reserved Forest of Udhagai North Range of the Nilgiris Forest.

In this regard the District Forest Officer, Nilgiris Forest Division, Udhagamandalam has recommended and submitted the Part-II of Form –A the forest area diversion proposal for 0.225 ha of forest land to a length of the road is 250m and width of the road is 9.00 m.

In the reference 1<sup>st</sup> cited above the Principal Chief Conservator of Forests (Head of forest force) has raised queries and requested to corrected copy of the rectification proposal. Hence it is to submit that the following shortcomings has been rectified and submitted for further action

- i) In the Section A-3 xvii of part-I of Form – A of Document in support of the Competence/authority of the person making application to make application behalf of the user agency has been uploaded

- ii) The corrected Kml file for the length of the road is 250 m and a width of the road is 9.00 m has been uploaded and submitted in the online web portal.
- iii) Documents uploaded under additional details section in Sl.No.5,6 of Chitta copy and Sl.No.8 of partnership power of attorney has been uploaded and is now opened
- iv) The forest area required by the user agency of 0.36Ha has been restricted to 0.225 which is the barest minimum extent require for the project (250mX9.00m=0.225Ha) is sufficient. Accordingly the details in part-II of the form A and area details has been changed to 0.225 Ha.
- v) The details in Part-II of forma A on area details on area to be diverted has been changed to an extent of 0.225 ha
- vi) It is submit that the wild animals movements like, Indian Gaur, Sambar deer, Wild boar, Indian porcupine, Barking deer, Black naped hare & Malabar giant squirrel are presenting. Hence Part-II of Form-A section modified accordingly.

Since the area of the proposed diversion is less than one hectare, hence no CA land is insisted. However compensatory Afforestation plan will be implemented in the degraded Forest land over an extent of 1.08 Ha of Forest land in bearing survey No 872, Aramby Section, Muthinad Beat, Wenlockdowns RF of Udhagai North Range of this division has been identified and submitted along with the relevant records

Further it is submit that with the hard copies of the above documents is attached for kind reference.


