
Sir,

I am directed to refer to Your letter No.NHIDCL/J-K/FC/2016/Bo-NMS/Vol-I/1374 dtd 02.03.2017 your letter on the subject cited above, seeking permission under the Forest (Conservation) Act, 1980 for change of User Agency from Border Road Task Force (BRTF) to National Highway Infrastructure Development Corporation Ltd. (NHIDCL).

In this connection, I am directed to say that the proposal was submitted to the MoEF & CC for according permission for change of User Agency. The MoEF & CC, after careful consideration of proposal, has authorized the State Govt. to accord permission for change of User Agency vide its letter F.No.11-186/2016-FC dtd 7th September'2016.
