**Sub:** Connectivity for arranging power supply to an extent of 36 MVA on 220 kV voltage class in favour of M/s Resources Concentrates Pvt Ltd for their Iron Ore Pelletisation plant proposed at Somalapur village from 220/66/11 kV Badeladuku (Kudligi) sub-station in Sandur Taluk, Ballari District .

With respect to the above, the subject was placed before the 35<sup>th</sup> PSC meeting and approval is hereby accorded for arranging connectivity to an extent of 36 MVA on 220 kV voltage class in favour of M/s Resources Concentrates Pvt Ltd (earlier known as M/s Karnataka Ferro Concentrates Pvt Ltd) for their Iron Ore Pelletisation plant proposed at Somalapur village from 220/66/11 kV Badeladuku (Kudligi) sub-station in Sandur Taluk, Ballari District under self-execution, with the following conditions:

- I. The applicant shall construct 220 kV SC line on DC towers, for a distance of 30.0 kms, using Drake conductor from their site to 220/66/11 kV Badeladuku (Kudligi) Sub-station, by establishing 220 kV terminal Bay, metering cubicle with main meter & check meter as per KPTCL specification at 220/66/11 kV Badeladuku (Kudligi) Sub-station under self-execution scheme.
- II. The applicant has to purchase adjacent land at 220/66/11 kV Badeladuku (Kudligi) sub-station for construction of 220 kV terminal bay, to avoid line crossings .

- III. The applicant has to carry out necessary modifications & extensions as per site requirement at 220/66/11 kV Badeladuku (Kudligi) Sub-station for construction of their 220 kV terminal bay .
- IV. The earlier connectivity approval communicated vide T.O letter no: CEE(P&C) /SEE(Plg)/EEE(Plg-N)/KCO-91/F-34032/2015-16/409-415, Dated:07.04.2016 for 18MVA in favor of M/s Karnataka Ferro Concentrates Pvt Ltd. and 66kV TB allotted at 220 kV Badeladuku (Kudligi) sub-station during 67<sup>th</sup> TB meeting held on 08.07.2016 stands cancelled.
- V. Any ROW issues has to be solved by the applicant itself.

The above works shall be executed by the applicant under self-execution.

## **PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Proposal of M/s. Resources Concentrates Private Limited for change of name of the company and other amendments to establish "Iron Ore Pelletisation Plant" at Somalapura Village, Sandur Taluk, Ballari District.

### **Preamble:**

The project proposal of M/s. Karnataka Ferro Concentrates Private Limited to establish a "1.20 MTPA Iron Ore Pelletisation Plant" with an investment of Rs. 226 crore at Somalapura Village, Sandur Taluk, Ballari District was approved in the 25<sup>th</sup> SHLCC meeting held on 14.07.2011. Accordingly Government Order No. CI 196 SPI 2011, dated 22.08.2011 was issued read at (1) above.

In the 27<sup>th</sup> SHLCC meeting held on 13.04.2012, the committee considered the enhancement of investment and power requirement as follows:

- To incorporate the enhancement of Investment from Rs.226 crore to Rs.358 crore.
- Power requirements from 15,000 KVA to 18,000 KVA

Accordingly Government Order read at (2) above was issued.

Further in the 37<sup>th</sup> SHLCC meeting held on 27.03.2015 committee approved the following amendments for the project.

- To increase cost of the project from Rs.358.00 to Rs.890 crore.
- To increase the power requirements from 15 to 18 MVA to be supplied from GESCOM.
- To increase the land requirements from 196.51 acres to 277.36 acres.
- To increase the water requirements from 400 KLD to 5000 KLD

Accordingly, Government Order read at (3) above was issued.

43<sup>rd</sup> SHLCC meeting held on 01.02.2016 approved the following:

- Inclusion of 3.5 MTPA Pellet Feed Plant.
- Change of village name as Somalapura instead of sompur.
- Land requirement from 196.51 acres to 277.36 acres as SUC through KIADE.

Accordingly, Government Order read at (4) above was issued.

On the request of the Company, the proposal for amendments was discussed In the 53<sup>rd</sup> State High Level Clearance Committee (SHLCC) meeting held on 23.03.2020 and committee approved the proposal.



Accordingly Government Order read at (6) above was issued.

On the request of the Company in the Government Order read at (8) above, the Government has accorded approval for the following:

1. Change of name of the company from M/s. Karnataka Ferro Concentrates Private Limited to M/s. Resources Concentrates Private Limited.
2. Increase the Peletisation Plant capacity from 1.2 MTPA to 3.2 MTPA in addition to 3.6 MTPA Pellet Feed Plant.
3. KIADB to acquire and allot additional land of 163 acres in addition to 277 acres in different Sy. Nos. of Somalapura village, Sandur Taluk, Ballari District with consent of land owners.
4. Additional 1600 KLD water in addition to 5000 KLD water from overflow of water from TB Dam during rainy season to store the requirement and Sewerage Treatment Plant, Sandur, subject to availability and necessary permission from WRD and Sandur Municipality.
5. 18 MVA power in addition to 18 MVA from GESCOM.
6. Additional Investment of Rs.173 crore in addition to Rs.890 crore
7. Additional employment for 150 people in addition to 500 people.
8. Extension of time by 2 years to implement the project, with a condition that further extension of time will not be granted.

On the request of the company, in the 87<sup>th</sup> Land Audit Committee (LAC) Meeting held on 09.09.2021, the Committee decided to recommend to SHLCC for transfer of SHLCC approval from M/s. Resources Concentrates Private Limited to M/s. Resources Pellets Concentrates Private Limited.

In the 35<sup>th</sup> SHLCC meeting held on 14.05.2014, the committee noted that some of the projects approved earlier, which require minor changes in the Government Orders needed to wait till the subsequent SHLCC or SLSWCC meeting took place and this would delay the implementation of the projects. After detailed discussion, the committee authorized Additional Chief Secretary to Government, Commerce and Industries Department to amend the Government Orders / Approval letters and to place such issues before the next SHLCC/ SLSWCC for ratification.

Under this provision, decisions of the 87<sup>th</sup> LAC and on the request of the Company, the Commissioner for Industrial Development and Director of Industries and Commerce vide file read at (9) above has recommended to

consider the following amendment proposal of M/s. Resources Concentrates Private Limited and to issue Government Order.

- Transfer of SHLCC project approval from M/s. Resources Concentrates Private Limited to M/s. Resources Pellets Concentrates Private Limited.
- Permission of the concerned department for utilization of borewell water until water for the project is drawn from T.B. Dam and storage facility is constructed in the site

Hon'ble Chief Minister has accorded approval to the proposed proposal of M/s. Resources Concentrates Private Limited.

Hence the following order.
