With reference to the above, it is submitted, the Principal Chief Conservator of Forests, (HoFF), AP, Hyderabad has communicated the proposals for diversion of 365.66 Ha of Forest land in Compt.Nos.113,114,115,116 & 117 of Gani RF, Kurnool Division for establishment of Integrated Renewable Energy Project, Pinnapuram in f/o M/s Greenko Energies Pvt. Ltd., Hyderabad.

Further, they are also requested to examine the proposal in the light of guidelines issued regarding RoFR Act vide MoEF Lr.No.11-9/1998-FC(Pt), dt.05.07.2013 linear/other than linear projects duly certified by the District Collector for evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other traditional Forest Dwellers (RoFR) Act, 2006 duly annexed to each of the proposal. Further, they are also requested to submit the proposals in a complete shape in information in Part-II with specific recommendation, within stipulated time to the Divisional Forest Officer, Kurnool along with information in check slip, for further processing.

Further, it is submitted that, the user agency has conducted the Gramasabhas in Pinnapuram village of Panyam Mandal, Gani village of Gadivemula Mandal, Bramhanapalli and Kalva villages of Orvakal Mandal/ tehsil of Kurnool District and discussed about the Diversion of 365.66 Ha of Forest land in Compt.Nos.113,114,115,116 & 117 of Gani RF, Kurnool Division for establishment of Integrated Renewable Energy Project, Pinnapuram in f/o M/s Greenko Energies Pvt. Ltd., Hyderabad; during the course of Gramasabhas revealed that there are no claims existing in the area proposed for diversion, however, written consents have been obtained from Gramasabhas of Pinnapuram village of Panyam Mandal, Gani Village of Gadivemula Mandal, Bramhanapalli and Kalva villages of Orvakal Mandal/ tehsil of Kurnool District stating that there are no Forest Dwellers eligible under RoFR Act, 2006 in Gani RF and there were no any objections raised in the Gramasabha conducted on 27.07.2018 at Pinnauram village, 12.07.2018 at Gani Village, 13.07.2018 at Bramhanapalli village, 18.07.2018 at Kalva village.
