Plantation Model:

As, the area being diverted is less than 01 Hectare and involves no tree felling, it comes under the purview of section-2.6(i)(b) under Compensatory rules of Handbook of guidelines for effective and transparent implementation of the provisions of Forest (Conversation) Act, 1980 reproduced as:

"In the following cases, cost of plantation (including ten years maintenance) of ten times the number of trees likely to be felled or specified number of trees as may be specified in the order for diversion of forest land (subject to a minimum no. of 100 plants), shall be levied from the user agency towards compensatory Afforestation."

Compensatory afforestation over an area of 0.11 Ha. of degraded forest land is proposed to be raised. The area selected for this purpose is Tikri Forests (19a/U), Beat Tikri, which is a degraded forest area and has been proposed for CA. Presently the area supports scattered Chir (Pinus roxburghii) and other broadleaved trees. Whole of the plantation of 0.11 ha will be raised in a one Patch. The area identified for plantation has also been shown on the attached map. The species to be planted will be mainly Chir and some local Mixed Broad leaved species. Total financial outlay for compensatory plantation scheme is Rs. 68,489/-. The monitoring will be done as per existing monitoring mechanism in the Forest Department at present and also as per G.O.I instructions.
