**ORDER:-**

The Executive Engineer, Bhadradi Kothagudem District has submitted a letter the works 'Improvement of

- 1) Errampadu to Battigudem road from km 0/0 to 3/0.
- 2) Rallapuram to Battigudem from 0/0 to 3/0.
- 3) Thaliperu dam to Rallapuram from km 0/0 2/0.
- 4) Thippapuram to Battigudem from km 0/0 to 4/0.
- 5) Uyyalamadugu to Thippapuram from 0/0 to 3/0.
- 6) Thippapuram to Bathinapally via Chennapuram from km 0/0 to 10/3045
- 7) Yellandu to Gundala from 0/0 to 51/6 extra land

in Charla Mandal of Bhadradi Kothagudem District' have accorded administrative sanction for an amount of Rs. 15.699 Crores vide 1<sup>st</sup> reference cited under SCA Scheme. The road of Thippapuram to Bathinapally via Chennapuram was sanctioned work reference 2<sup>nd</sup> cited for Rs. 10.00 Crores under RDF Scheme.

In this regard, the existing roads are single lane with earthen surface. Hence it is required to improve them to all whether roads by proposing WMM and Bituminous

concrete in addition to constructing C.D works, Wherever necessary to have proper transportation facilities to the villages.

Further stating that, the District Collector, Khammam vide proceeding No. Rc.No. E1/1805/2016, Dt. 13.06.2016 an extent of 60.520 Ha, Forest land is affected in the road widening process under the forest jurisdiction of Bhadrachalam. The details are as follows.

Further submitted, stating that the stage-I approval for the works of R Kothagudem to Kurnapally from Km 11/6 & Seethanagaram to Kurnapalli road from Km 0/0 to 20/0 were approved vide Lr.No. MOEF&CC, GOI, Regional Office, Chennai Lr.No. 4-TSC120/2018-CHN/0620 &0621, Dt. 27.04.2018 communicated by the prl.C.C.S.(HOFF), TS, Hyderabad Rc.No. 2238/2016-FCA2, Dt.10.05.2018( 39.911 Ha). The stage -I approval for Thippapuram to Chennapuram road from km 0/0 to 8/0 is pending. Hence, the balance compensatory Afforestation land towards diversion of forest land for the road Tippapuram-Chennapuram for an extent of 22.839(62.75-39.911) Ha. is with the forest department .

Hence, they have request to kindly arrange through authorities for identification and handing over of balance compensatory aforestation land to District Forest Officer, Bhadradi Kothagudem District to an extent of 11.934 (34.773-22.839) Hectares for submission of forest proposals through the reference 3<sup>rd</sup> cited..

Vide reference 4<sup>th</sup> cited, they have submitted and stating that as per instructions of the Principal Chief Conservator of Forests ( Head of the Forest Force), Telangana State, Hyderabad, the Forest Divisional Officer, Palvoncha has conducted DGPS survey to the proposed land for notification of Jagannadhapuram Extn-I Forest Block U/s 24 of AP,

Forest Act, 1967 and submitted the report as per DCFPC survey the extent of area is notified as Ac:Rs 00 gts 15 02 Ha and notified project whose details are shown below.

In this regard, District Forest Officer, Bhadrachal Kothagudem has requested to the reviled proceeding may be issued to the entire area to an extent of Ac:Rs 00 gts 15 02 Ha i.e 22.51 Ha CA area is already earmarked for the above (3) projects in lieu of diversion of forest land to an extent of 22.51 Ha and balance Land bank area of 5.03 Ha and excess area of 7.48 Ha may be earmarked for any ongoing projects for which CA area is required in lieu of diversion of forest land and the instructions may be issued to the concerned Tahsildar to mutate the entire land area of 35.02 Ha to the Forest Department as the entire area is under control of the Forest Department.

The Total extent of compensatory afforestation land towards diversion of forest land by the requisition by user agency is 34.773 Ha.

The CA land available with the forest department is 34.949 ( 22.839+12.11) as against requirement of 34.773 Ha

In view of the above, Tahsildar, Aswaraopeta and Dammipeta is hereby directed to handover the advance possession to an extent of 35.02 Hectors to the District Forest Officer, Bhadrachal Kothagudem for compensatory afforestation of road winding at Charla Mandal of Bhadrachal Kothagudem district under cover of Panchanama under supervision of Revenue Divisional Officer, Kothagudem immediately.

The District Forest Officer, Bhadrachal Kothagudem is hereby directed to taken over the afore said land from the Tahsildar, Aswaraopeta and Tahsildar, Dammipeta and report compliance.

Tahsildar, Aswaraopeta and Dammipeta is hereby make necessary entries to afore said land by concern Village Revenue Officers in Revenue Records and report compliance at on early date.
