
In inviting a kind reference to the above subject it is to intimate that the PCCF, Bhubaneswar has made some observation on proposal for diversion of forest land for the work "Widening of existing 2-lane to 2-lane with 1.5m wide paved shoulder from Km 0/0 to 81/0 and 93/0 to 119/00 of NH-157 on EPC mode". It is to mention that the para wise compliance to the observation as follows:-

- i)      The Collector, Kandhamal has issued the revised FRA certificate for diversion of forest land of 7.722 Ha.
- ii)      The tree enumeration list of Non-forest Government land has been submitted in hard copy to your good office.
- iii)      The index DGPS map has been authenticated by the Tahasildar, Khajuripada. Hence you are requested to authenticate to said maps.
- iv)      The cadastral map has been authenticated by concerned Tahasildar.
