

13	Recommendations of the Committee (should include length in kilometers, extent of forest land additionally required for completing the work, expenditure to be incurred on engineering/vegetative works necessary for stabilizing the soil/boulders an upper and lower sides of the road, etc).	The committee recommended the widening of road and fresh construction from R.D. 0/0 to 2/003 so that the road is made all weather & the road sides are stabilized. Separate muck dumping plan will be prepared for stabilization of excavated soil.
