## 1. Project Details:

 Short narratives of the proposal and project/scheme for which the Forest land is required.

The Rural connectivity road connecting the habitation of Samdoche and Upper Gaikhana has been a long pending demand of the local residents and public of the concerned area. Based on the demand, the project was placed and subsequently sanctioned during the financial year 2016-17 under the PMGSY Phase XI. The proposed road has a sanctioned length of 4.23 KM and the total cost of the project is Rs 362.36 Lakhs. Initially, the proposed alignment was supposed to pass through private land and khasmal based on the survey record of 1979-80. However, it has now come to light that 890 mtrs of the proposed alignment which was earlier thought to pass through the private land and Khasmal is a Reserve forest area according to the survey record of 1950-52. The alignment was selected due to obligatory points like the public crematorium and Samdoche Primary school in between and also considering the long term topographic stability.

  The Total Cost of the Project is Rs 362.36 Lakhs
- (iv) Justification for locating the project in the forest area:

  There were obligatory points like the public crematorium and Primary School at

  Samdoche along the alignment which were required to be connected on priority. As per
  the survey record of 1979, the maximum proposed alignment was under the possession
  of the local public and partly within khasmal. However, there is dispute regarding the
  possession of the land as of now in regards to the survey records of 1950-52 and 197980.
