SUB: Letter of Termination of RO Dealership under the name and style of M/s Rama Filling Station, Dudhan, Patiala- Pehowa Road, Dist Patiala (Pb)

This letter is in furtherance to our Show Cause Notice dtd: 12.06.2012 vide which you were asked to show cause within 15 days of the receipt of that letter as to why action against your RC dealership should be not taken for breaching Clause 11 (w) of the Dealership Agreement which prohibits the dealer from assigning its interest under this agreement.

We are in receipt of your reply dtd: 03.07.2012 vide which you have reiterated that your brother has been operating the RO as per the will of your father Sh. Ram Swarup. Vide the letter you have once again requested to transfer the ownership of M/s Rama Filling Station in favour of your brother Sh. Anil Garg. Besides the above you have failed to submit any cogent explanation for breach of Clause 11 (w) of the Dealership Agreement.

You have already admitted that the firm is being run by your elder brother Sh. Anil Garg and therefore all the documents of the firm are being signed under his name. Further from the perusal of the Income tax return(s), VAT return(s), audited balance sheet(s) for financial year(s) 2009-10 & 2010-2011, statement of Bank account and certificate from your Banker it has been established beyond doubt that M/s Rama Filling Station was being operated by your elder brother Sh. Anil Garg.

It may be appreciated that assigning your interest in favour of your elder brother Sh. Anil Garg is unauthorized as neither any prior written permission nor any reconstitution of your firm has been approved by the Corporation.
