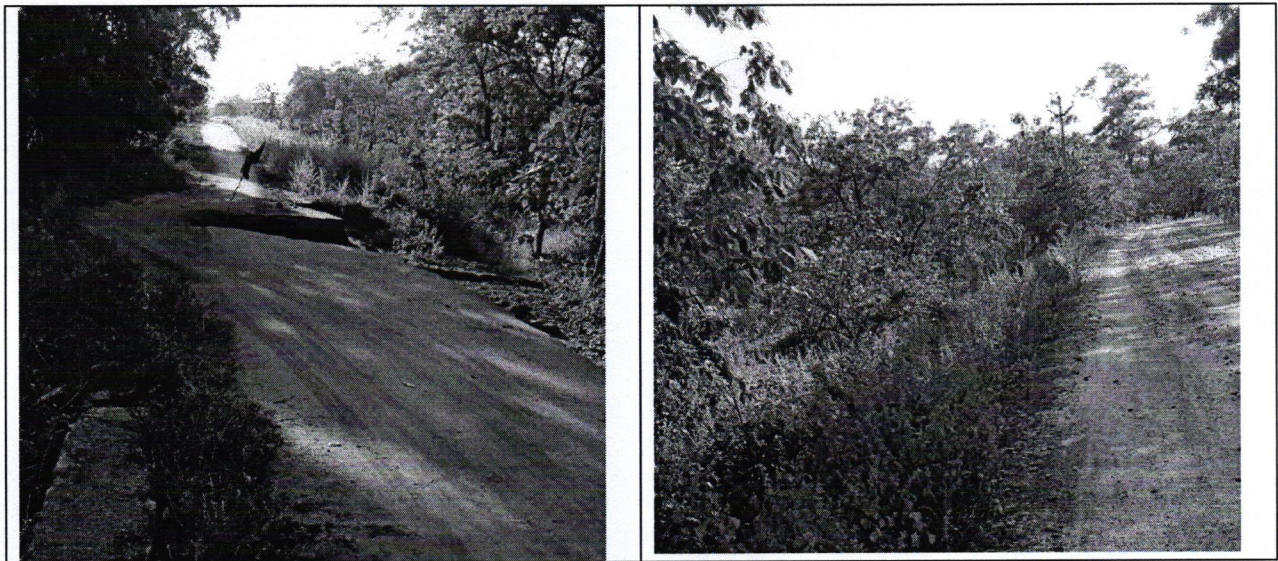

The proposed Pipe line is passing through Jodeghat, Ginnedhary, Kerameri and Tiryani Ranges of Asifabad Division. The total area required for diversion in Asifabad Division in Powerguda Segment 22/17 is 20.484 Ha. The length of the pipe line is **198942.373** RMT. in the above compartments. For pipe line 18.336 Ha and for structures 2.148 Ha area is required for diversion.



In the proposed diversion area, *Terminelia temontosa* & *Chloroxyon sweietenia* are unique species of this area. No protected archaeological / heritage site / defence establishment or any other important monument is found in the area.

The area is having different type of vegetations, which is having 0.1 to 0.3 Density.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project.

No violation against the Forest Conservation Act 1980 has been carried out by the User Agency.

Further, it is submitted the User Agency has Submitted the ROFR Certificate issued by the District Collector erstwhile Adilabad District. **There is no tree growth in proposed diversion area.**

Hence, the proposed of diversion of 20.484 Ha. (FCA Proposals) **Iodeghat, Ginnedhary, Kerameri and Tiryani Ranges** for laying of Drinking Water pipe line and constructions in Powerguda Segment 22/17 for providing safe drinking water to Kumrabheem Asifabad District under Telangana Drinking Water Supply Project in favour of Superintendent of Engineer, TDWSP (RWS & S) Circle Nirmal is **RECOMMENDED.**
