In this regard, it is submitted that the observations raised by the Govt of India vide communication under reference have been attended by the User Agency and reply of the same is furnished in- annotated manner as under:-

1. There is difference in employment likely to be generated, mentioned against column No.E in online part-I and given in hard copy of the proposal. Against column No. E(ii), 20 and against E(iii) 7500 has been mentioned whereas in hard copy of part-I against column No.I (vi), only 7500 mandays has been mentioned. The employment details given in online prt-I and placed in hard copy should match. Necessary corrections are required to be made in the employment details in hard copy of part-I.	The complete employment detail on. Part No-I online E (ii) &E (iii) has been corrected. There is 685715 mandays provision in this proposal. Accordingly, necessary information has been uploaded in MoEF Portal E (ii) and E (iii) and revised part-I is enclosed herewith, in quadruplicate for further necessary action please. Further User Agency has intimated that after the completion of this proposal the regular staff presently working shall be maintain this project.
2. CA has been proposed in terms of number of plants, thus the detail of patch is not required to be mentioned against column No. 13(i) to 13 (iv) in online part-II. Further the CA scheme and maps are required to be uploaded against additional information detail.	The C.A.. Scheme Patch has been proposed in Land Bank Nagdhar DPF, Shivabadra Block <sup>not</sup> of Paanarsa Range. The necessary entry has been made in MoEF portal 13(i) to 13 (iv) on line Part. II and CA Scheme and map have been uploaded in MOEF Portal as additional documents.
