**Subject: NOC for construction of 1320 MW thermal power plant in Mirzapur
Distt of Uttar Pradesh- reg.**

Sir,

I am directed to refer to your letter No. WEUPPL/DLI/MoD/2011/1, dated 07.01.2012 on the above subject and to say that Ministry of Defence has no objection to construction of chimney 1320 MW Thermal Power Plant near Dadri Khurd Village, Sadar Tehsil in the District of Mirzapur, Uttar Pradesh by M/s Welspun Energy UP Private Limited subject to the following conditions:

- (a) The vertical extent (highest point) of the chimney shall not exceed 275 meters above ground level / 455 meters above mean sea level.
- (b) Standard obstruction markings and lightings on the chimneys shall be provided by the company. Provision shall be made for standby power supply to the light to keep them 'ON' during power failure.
- (c) High intensity flashing white lights shall be installed on top of the chimney followed by lights at uniform interval of 105 meters to ground level by the company as per International Civil Aviation Organisation (ICAO) standards as stipulated in ICAO Annex-14. The lights shall be kept ON at all times.
- (d) Periodic maintenance of obstruction marking and lightings to be carried out by the company at regular intervals to keep them in visible/ serviceable condition.

- (e) No other extension/ tall structure to be constructed / added by the applicant to the chimneys.
- (f) NOC from Airports Authority of India may be obtained, if necessary.
- (g) Validity of this NOC is five years from the date of issue. If construction for which NOC has been issued, does not complete within five years of issue or found to be in deviation from original proposal the NOC shall be deemed null and void. It will be the responsibility of the applicant to obtain fresh NOC for the proposal.
- (h) The commencement and completion of the works and installation of obstruction lights should be intimated to AOC, AF Station, Allahabad and Directorate of Ops (Nav), Air HQ, Rafi Marg, New Delhi.
- (i) Required security clearance should be obtained through MHA/ IB and the other agencies of the foreign Nationals /Indian representatives to be employed by the Company in India.
