Kangra, H.P. for the construction of Lower Bhagair Small Hydel Project (1.00 MW) HEP, within the jurisdiction of Chamba Forest Division, Distt. Chamba, Himachal Pradesh (Online Proposal No. FP/HP/HYD/49792/2020).

This has reference to the observations raised by the Integrated Regional Office, MoEFF & CC, Shimla vide their letter ref. File No. FC/HPB/01/77/2021 dated

01-06-2022. In this connection we submit the pointwise comments as under:-

- That as desired we are uploading the Layout Plan of Diversion area in the web portal at designated location.
- That due to calculation error there is a difference in the diversion (length to breadth) in the component-wise breakup document which has now been rectified after reviewing the same.
 - The revised component-wise breakup is being submitted as per 'Table-2' annexed herewith.
- 3. That through an oversight the wrong figures were picked up and were mentioned inadvertently in the component-wise breakup document in Inspection Report. Now the correct figures matching the component-wise breakup as per 'Table-2' has been incorporated. We may reiterate that insertion of these corrected figures in the component-wise breakup in the component-wise breakup in the component-wise breakup.

Joint Inspection Report, does not affect the component wise area to be diverted in any manner and remains unchanged as such Further at Sr. No. 11 of Joint Inspection Report, area of Forest land in first column has been wrongly shown as 0.00.08 due to typographical error. Now the correct figure as 0.00.80 has been inserted. Again the total area to be diverted remains unaffected.

- 4. That the negotiations regarding evacuation agreement are still going on with the management of Kiunr SHEP (5 MW) owned by Snowdew Hydel Project (P) Ltd. We are sanguine that agreement shall be signed with them before the signing of PPA. As per the revised guidelines of HIMURIA the PPA shall be signed six months before the commissioning of our project. We assure you, Sir, that copy of agreement shall be provided as & when the same is reached upon.
- That the shortcomings pointed out in the digitized map are being attended to as under:-

- Legends have been marked on the map.
- b. The boundaries of PAs and their ESZs are marked on the digitized map on the basis of the digitized map of the boundaries of Tundah WLS and ESZ of Kugti issued by DFO Wildlife Division, Chamba.
- That the map is being uploaded in the web portal.
- d. That the rest of the desired information such as distances of HEPs from ESZ of Kugti and Tundah WLS etc. are being shown in the chart being annexed herewith.
