The pointwise reply of the observations/shortcomings as raised by your good office vide above referred letter is as under: -

1	As per the KML file, the diversion area is slightly steep and prone to erosion. Therefore, state Govt. may provide details of the mitigation measures to be adopted to arrest the accelerated soil erosion/land slide during/after execution of project. Additionally, the state Govt. may submit soil and moisture Conservation Plan along with detail cost of its implementation as per MoEF & CC vide latter No. FC/11/48/2021-FC dated 07.06.2022	The Mitigation measure to be adopted to arrest the accelerated soil erosion/land slid during after execution of project has been uploaded in additional information column at Sr. No. 24. of online Part-1.
2	It has been observed that proposed Diversion Area is 2.899 hac. However, as per the DSS analysis, the area calculated by DSS software is 1.81 hac. Therefore, same may be reviewed and revised KML file with correct area figure be provided.	The KML file has now corrected and uploaded the same in designated place of online Part-1.
3	The Muck dumping site is proposed in forest land. The suitable non-forest land/private land may be explored for disposal of muck. Also, a separate list of trees standing in muck dumping site may be provided /Uploaded, if muck dumping is proposed in forest land. 5	It has been observed from KML file that the dumping sites (6) is in very steep slope from where debris can be easily rolled down into Road/River downhill side. Therefore, the State Govt. may submit mitigation measures to be adopted , so that debris could not be rolled down into the Road/River downhill side. 6	In the KML file , there are 6 number of dumping sites, however in Part-I , component wise break-up there is only one dumping site mentioned. Therefore , State Govt. may reverify and review the same .	Necessary correction has been made in online Part-1, against component wise breakup.
7	The State Govt. may provide the slope, capacity , cross section dimensions of each dumping site.	The slope, capacity , cross section dimensions of each dumping sites has been uploaded in additional information column at Sr. No. 31 of online Part-1.
8	i) It seems from KML file, the alignment of the road from Geo-coordinate Latitude 31o 25'54.50" N Longitude 77o 31'37.78" E to Lat. 31o 23'51.76" N Long. 77o 31'39.74" E is not found justifiable. The State Govt. may review and revise the same accordingly ii) In the KML file, possibility may be explored to connect the starting point from already existing road Geo-coordinates i.e. Lat. 31o 23'40.70" N Long. 77o 31'0.50" E instead of Lat. 31o 23'26.44" N Long. 77o 30'46.71" E to reduce the felling of trees as well as to minimize the dimension of forest land. 11	As per the description given in Part-1, Additional Information Details, Column (19), area calculated as per the length and width given in the extant proposal is not matching with the total area of the proposal. Therefore, State Govt. may justify and review the same. 12	The status of proposed CA land may be provided, whether it is a Waste land under HP Govt. notification, 1952 or is notified as UPF/DPF under IFA, 1927. The copy of relevant document may be provided	Pertains to Forest Department.
13	Reclamation Plan duly authenticated by DFO concerned is required to be submitted	The Reclamation Plan duly authenticated by DFO concerned has been uploaded in additional information column at Sr. No. 33 of online Part-1.
