1. A proposal has been received by this office from PMGSY Division Udhampur-I for diversion (under FCA, 1980) of 0.255 ha of forest land for non-forestry purpose. The subject envisages the use of forest land for construction of road from Barkunda to Kharwa. The site inspection of the land involved in the proposal has been done by me on 22-05-2021. On inspection of the site, it is found that the land required by the User Agency is a forest land (Sudhmahadev Conservation Reserve) measuring 0.225 ha. The requirement of forest land as proposed by the User Agency in Col. 2 of Part-I is unavoidable and is barest minimum required for the project.

Anil Kumar Atri SFS, Wildlife Warden Jammu, Sh. Rakesh Kumar Sharma, Range Officer Wildlife Range Udhampur, Sh. Mushtaq Mohd, Block Officer and concerned field staff. During inspection, it has been found that the proposed road from Barkunda to Kharwa having total length of 5.85 Km passes through Wildlife area in Co.109 of Sudhmahadev Conservation Reserve in 01 no. of stretche with total length =375m as per below details



- The net Wildlife area that needs to be diverted from Conservation Reserve is 0.225ha and 26 nos. of trees of Conifers species (*Pinus roxburghii*) are coming under the alignment of the proposed road.
