The subject envisage the use of forest land for construction of 132/33 KV Grid Sub-Station at village-Bora, Thana/ Thana No. Hunterganj-133, Plot No. 40, having an area of **4.04 ha.** The site inspection of the land involved in the Proposal has been done by me on dated **03.06.2019** along with the Forest Range Officer, Hunterganj & staffs:-

On inspection of the site, it is found that land required by the user agency is a forest measuring **4.04 ha.**


The requirement of forest land as proposed by the user agency in Col-2 of Part-I is unavoidable and is barest minimum required for the project.
