- I. The proposed area is in Sy No 63 of hariharapura village, kasaba hobli, Shikaripura Tq, Shivamogga Dis. it is a Revenue land and it is mentioned as "**Sarkari Muppattu**" in RTC Colum No.9
- II. The proposed area for CA land is an old teak plantation area and the proposed CA land is adjoining to the Hariharura Minor Forest. The major species found here are *Tectona grandis*, *Terminalia paniculata*, *Xylia xylocarpa*, *Anageisus latifolia and Lagerstromia lanceolata*.

- III. The proposed area have wild animals like wild boar, deer, sambar, monkeys, etc
- IV. This proposed land is plain area.
- V. Annual rainfall here is 1500mm to 2400mm and this area do not have any channels/tanks.
- VI. On one side of the proposed land residential area of ambligola village is present and on the other side Hariharapura minor forest area is there.
- VII. Proposed land is 296 meter away from Hariharapura MF and also adjoining to Hariharapura CA area (Notifiaction Number KFD-01-PCCF(Hoff)-01-2020 Dated : 19.06.2020)
- VIII. Concerned area is not included in any section-4 proposed area or in statutory forest proposed list and it is purely a revenue land.
 - IX. The proposed CA land is free from encroachment roads and buildings.
