With reference to the above, I am submitting herewith the reply to the queries
sought vide ref(2) from that office.

Query:

1. JOINT SURVEY/SECOND JOINT VERIFICATION IS TO BE DONE

(a) Joint survey/ inspection done with the Munnar forest division surveyor on 24/09/2020
on the required forest land

2. KML FILE UPLOADED TO BE CORRECTED

After the joint survey with forest surveyor new .kml file of transmission line inside forest
area prepared incorporating with: -

(a) 220/110 kV MCMV tower locations

(b) Both sides 2 meters additional ROW required

(c) 220/110 kV Line drawing

(d) Forest Janda locations outside the Existing ROW from location KP 55 to KP 59

(e) Lines plotted with 12.2 mtr minimum height clearance required inside forest.

Soft copy of the new .kml file submitted at the office of the Divisional Forest Officer,
Munnar Division.

Additional ROW required from location KP 55 to KP 48 which is about 3048
m/1.2192Ha

3. APPROACH ROAD AREA TO BE ADDED IF NECESSARY

Finally it is decided that manual work to be arranged by the contractor inside the forest locations. So the approach roads are not necessary.
