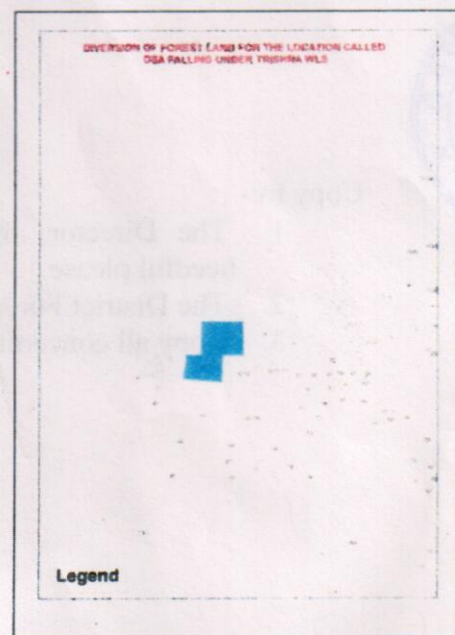
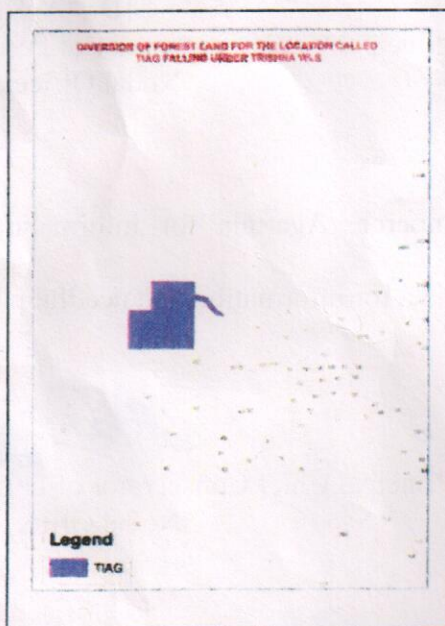
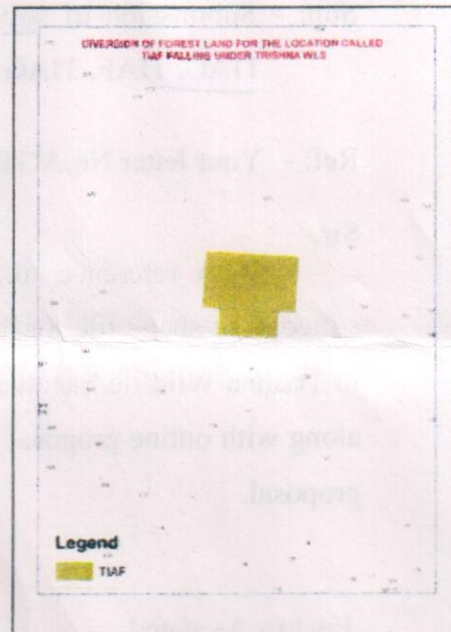
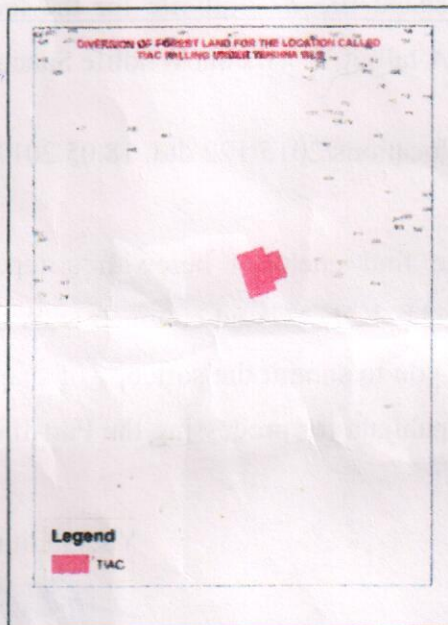
Location TIAF: 1.427 Ha
