<b>1 Project Details</b>  i) Short narrative of the proposal and project / scheme for which the forest land is required	The Government of Andhra Pradesh has accorded administrative approval to Rs.1701.00 Crores for Chintalapudi Lift Irrigation Scheme vide G.O.Ms. No. 207,I & CAD Dept., ( Irri. ),Dt. 24-10-2008. The scheme provides irrigation facility to an extent of 2.00 Lakhs acres/80972 Ha by lifting of 15.5 TMC of water from River Godavari in 15 mandals in the west godavari and krishna districts, and also provides drinking water to a population of 6.65 lac people and their cattle living in 160 villages. This scheme also serves water to the new proposed jalleru reservoir with a capacity of 8 TMC. This scheme also envisages the excavation of gravity flow main canal in a length of 68km including link canals and distributory net work facility to the above upland areas of 2,00,000 acrs. Some parts of this scheme found involving reserved forest area which becoming inevitable. Therefore an extent of 2497.449 hectares of forest land is required as detailed below.
