In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 03<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for Non-Forest purposes, it is certified that 30.5 Hectare of Forest Land proposed to be diverted in favour of Bina-Kakri Amalgamation Project of M/s Northern Coalfields Limited, Singrauli (Name of User Agency) for Mining (Purpose of Diversion of Land) in Sonbhadra district, Uttar Pradesh falls within the jurisdiction of Kakri Village in Duddhi tehsil.

## It is further certified that:

- a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire 30.5 Ha of Forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights committee(s) at Gram Sabha, Sub-Divisional Level and the District Level are enclosed as annexure 1, 2, 3.
- b) the proposal for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before Kakri Gram Sabha of Forest -dwellers who are eligible under the FRA
- c) the Kakri Gram Sabha(s), has certified that all formalities/processes under the FRA have been carried out, and they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and detail of proposed diversion. A copy of certificate issued by the Kakri Gram Sabha of village is enclosed as annexure 1.
- d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Kakri Gram Sabha present.
- c) the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Kakri Gram sabha have given their consent to it.
- f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.
