ORDER:-

In the letters 8th and 10th read above, the Sub Collector, Paderu has reported that the Executive Engineer PIU Division Paderu has requested to identify Government Land for an extent of Ac.55.00 Cts under compensatory afforestation required for forest clearance for the road works under PMGSY & RCPLWE grant in forest areas. The Sub Collector, Paderu has identified suitable Government land for the purpose of Compensatory Afforestation land in Bheemavaram Village of Gummakota Panchayat and Nandakota Village of Bheempolu Panchayat of Ananthagiri Mandal for handing over the same to Forest Department. The details are as follows.

Thereupon, the proposal of the Sub-Collector, Paderu has been forwarded to the DFO, Vizianagaram vide letter 9th read above to submit their feasibility report on the lands mentioned above.

The DFO, Vizianagaram has submitted his report vide letter 11th read above to the Chief Conservator of Forest, Visakhapatnam and marked a copy to the District Collector erstwhile, Visakhapatnam District wherein he has reported that, the above lands were inspected on 09.03.2022 along with user agency and Mandal Surveyor and certified that the above lands are suitable for compensatory afforestation. The details are as follows.

The Superintending Engineer, Panchayat Raj, Visakhapatnam vide letter 12th read above has stated that the Forest Officials have given their consent on the above lands and requested to issue necessary instructions to the Tahsildar concerned to handover the advance possession of land to the Forest Department and to initiate alienation proposal to transfer the CA Lands.

In view of the above, the Tahsildar, Ananthagiri Mandal is hereby directed to handover the advance possession of the land measuring an extent of Ha.12.11 (Ha.5.06 in Sy.No.104 of Bheemavaram Village & Ha.7.05 in Sy.No.4P of Nandakota Village) of Ananthagiri mandal with reference to the report of the DFO, Vizianagaram to the Forest Department in lieu of compensatory afforestation pending finalization of regular alienation proposals.

The DFO, Vizianagaram is requested to take over the advance possession of the above land measuring an extent of Ha.12.11 in Ananthagiri Mandal.

The Sub, Collector, Paderu is requested to monitor the entire process of handing over of advance possession to the DFO, Vizianagaram.
