## **ORDER**

Director, Energy Management Centre vide letter read as 3<sup>rd</sup> paper above has recommended for the allotment of 90 KW Vellakayam MHP identified near Kothamangalamthodu at Vellakayam in Vannappuram Panchayath of Thodupuzha Taluk to Shri.Y.Sleebachen, Charuvila Veedu, Chengamanadu P.O, Kottarakara as per Small Hydro Power Policy, 2012 issued vide G.O read as 1<sup>st</sup> paper above, as he has submitted all documents required and satisfied all the criteria for the project implementation.

Director (GEN-C & HRM), KSEBL vide letter read as 2<sup>nd</sup> paper above and Technical Committee for Technical Clearance of Techno Economic Feasibility Report of Small Hydro Power Projects for Implementation by Private Developers constituted vide Government Order read as 4<sup>th</sup> paper above have also recommended for allotment of 90 KW Vellakayam MHP subject to certain conditions.

Government have examined the matter in detail and are pleased to accord sanction for the allotment of 90 KW Vellakayam MHP identified near Kothamangalamthodu at Vellakayam in Vannappuram Panchayath of Thodupuzha Taluk to Shri.Y.Sleebachen, Charuvila Veedu, Chengamanadu P.O. Kottarakara as per Small Hydro Power Policy, 2012 issued vide G.O read as 1<sup>st</sup> paper above subject to the following conditions.

- 1. No compensation shall be due to the promoters of the VellakayamMHP if at any time KSEBL identifies and decides to implement scheme in the vicinity of the proposed MHP.
- 2. Implementation agreement shall not be applicable for project in own land category as the project allotment is not on BOOT Basis.
- 3. The whole responsibility of the project implementation including meeting with the technical requirement, safety, quality control and monitoring of the implementation of the project shall be with the project developer.
- 4. On allotment the developer shall remit the upfront premium at the rate of Rs. 15 Lakhs/MW.
- 5. The developer shall obtain all the necessary clearances from the departments concerned before starting construction of the project.
- 6. The developer shall periodically report the status of the project to the SHP cell of Power Department functioning in EMC.
