COMPENSATORY AFFORESTATION SCHEME

Compensatory Afforestation in respect of diversion of 0.69 ha of Forest Land for construction of Playground at 15h Mile J.N. Road, Kyongnosla in Gangtok District of Sikkim by Sports & Youth Affairs Dept., Govt. of Sikkim.

1. NTRODUCTION:

Proposal pertains to Compensatory Afforestation in respect of diversion of 0.69 ha of Forest Land for construction of Playground at 15h Mile J.N. Road, Kyongnosia in Gangtok District of Sikkim by Sports & Youth Affairs Dept., Govt. of Sikkim.

The forest land involved is 0.69 ha and the stipulation would be double the area proposed for diversion i.e 1.38 ha to be proposed for the raising compensatory afforestation to maintain ecological balance in the area.

The Ministry of Environment, Forest & Climate Change has prescribed the following guidelines for diversion:

- i. In all cases the legal status of forest land shall remain unchanged.
- ii. User agency would have to pay the cost of compensatory afforestation to the Forest Department.

3. INTEGRATED PROGRAMME / METHODOLOGY OF WORK EXECUTION

- i. Seedling Requirement: The requirement of seedlings may be met from the existing Nurseries of the Department on payment basis as per the approved rates. The existing nurseries will have to be provided with the seeds of mixed species including the cost of nursery implements used.
- **ii. Choice of species**: Mixed plantation of site-specific species indigenous fruit bearing and timberable species namely, *Abies densa, Juniperus recuvera, Rhododendron arboretum*, spp etc.
- iii. Executing Agency: Namchi (T) Division may execute the work under the supervision of State FCA Cell.
- **Monitoring and Evaluation:** All the activities under the Scheme may be monitored by a committee constituted for the purpose, Nodal Officer, Forest (Conservation) Act, 1980 and the representative from Ministry of Environment and Forests, Government of India concurrently and regularly.
