Subject: - Diversion of 0.1514 hac. of forest land for Rehabilitation and Upgrading of Existing Road to 2 lane with Paved Shoulder from end of Hamirpur bypass (Chil Bahal) to Bhangbar Section via Jwalamukhi (Package IV) of NH-88 (New NH-3 & 303) (Design Chainage- Km 138+295 to Km 175+270. Design Length-36.975 Km), within the jurisdiction of Dharamshala and Dehra Forest Division, Distt. Kangra.

DFO Dharamshala has sent proposal for the diversion of 2.1338 hac. of forest land (0.1514 hac. of forest land within Dharamshala Forest Circle) for the Rehabilitation and Upgrading of Existing Road to 2 lane with Paved Shoulder from end of Hamirpur bye pass (Chil Bahal) to Bhangbar Section via Jwalamukhi (Package IV) of NH-88 (New NH-3 & 303) (Design Chainage- Km 138+295 to Km 175+270. Design Length-36.975 Km) in the State of Himachal Pradesh. The details of Forest land to be diverted for non forestry purpose is given as under:-

The User Agency has not provided the non Forest land for raising for Compensatory Afforestation and as such entire Compensatory Afforestation scheme in 4.37 hac. degraded Forest land in P-29K Daulatpur C-1C in Kangra Range for Rs. 19,60,535/- in lieu of 2.1338 hac. of Forest land being diverted for the Rehabilitation and Upgrading of Existing Road to 2 lane with Paved Shoulder from end of Hamirpur bye pass (Chil Bahal) to Bhangbar Section via Jwalamukhi (Package IV) of NH-88 (New NH-3 & 303) (Design Chainage- Km 138+295 to Km 175+270. Design Length-36.975 Km) in the State of Himachal Pradesh, has been prepared and enclosed with the Proposal. The User Agency has agreed to pay the cost of Compensatory Afforestation and Net Present Value under the relevant provisions. As per check list of documents pertaining to the proposal is enclosed herewith in the proposal folders.

It is therefore requested that further necessary action into the matter may kindly be taken accordingly.
