Subject: - NOC/ Agreement regarding granting of ROW for Laying of Optical Fiber Cable from N.H. - 127 B (Rongrenggre Junction) to Williamnagar 8 km (8000 meters.)

Sir/Madam,

With reference to the subject cited above, I am to inform you that since you have signed the agreement and have submitted Performance Bank Guarantee @ Rs 250/- per running route meter amounting to Rs 20, 00,000.00 (Rupees Twenty Lakhs) only, (for a length of 8000 meters) with validity of one year, No Objection Certificate (NOC) is hereby granted by the undersigned for the above mentioned works provided the following terms and conditions are strictly followed:-

- i. The overhead is allowed by erecting the pole outside the road shoulder.
 - ii. The digging of trenches manually and use of excavator/ machineries is strictly prohibited except if Horizontal Directional Drilling machine is used beyond the road shoulder.
 - iii. The digging for erecting of poles should not be done at side drains.
 - iv. To change the direction to the other side of the road, crossing should be made through the existing culvert only and in no case crossing by cutting the pavement is allowed and in case of river crossing, the cable should be laid beyond the carriageway/crash barrier.
 - v. The constructional operation should in no way obstruct the free flow traffic movement of pedestrians.
 - vi. Loading and unloading of materials should not obstruct the vehicular traffic flow.
 - vii. The materials, spoils, etc should not be stacked, placed or dumped on the road side.
 - viii. In case of any accident during the process of excavation and laying of cables, the firms shall be wholly responsible for the cost and risk involved.
 - ix. The terms and conditions laid down in the agreement should be strictly adhered to, failing which the Bank Guarantee will be encashed.
 - x. In case of any or all of the above Terms and Conditions are not met with, this NOC for ROW permission shall be withdrawn at risk and Cost of the firm and no correspondence will be entertained thereafter.
 - xi. In case cutting of road pavement is necessary (Especially in built-up areas) estimate for restoration work as per current SOR (to be approved by the Chief Engineer) should be prepared and estimated amount should be deposited by the company with the Department for carrying out the restoration of the pavement by the department itself.
 - xii. The work shall be taken up in consultation with the Executive / Assistant Executive Engineer concerned and the start/Completion date should be intimated through the officer concerned.
- The Agreement has been registered in this office as No.PW/EE/W-nagar/Ag/07, of 2020 - 21.

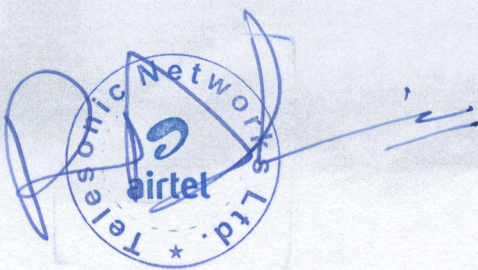
