## JOINT INSPECTION REPORT

We the undersigned have jointly inspected the areas proposed for Diversion in favor of **M/s SHIV SHAKTI ENTERPRISES**, Village KUNR, P.O. KUNR, SubTehsil Dharwala Teh. and District Chamba, Himachal Pradesh for setting up 1MW Lower Bhagair, Small Hydro Project on Bhagair Nallah. A tributary of Kiunr Khad then Ravi river downstream of Village Bhagair, Gram Panchayat Kunr, SUB-Tehsil DharwalaTeh. and Distt., Chamba, Himachal Pradesh on 28.11.2018. The project requires a total area of 0.79.03 hectares, for different components viz., Intakes, Desilting Tank cum Forebay, Water Conductor System, Powerhouse, Switchyard, and Tail Race Channel, and Muck Dumping Sites, approach road to Powerhouse and Transmission Line Power House to Inter-connection Point with the Switchyard of Power-house of Snow Dew Hydel Power Project at Kareri VPO Kunr, Sub-teh.
