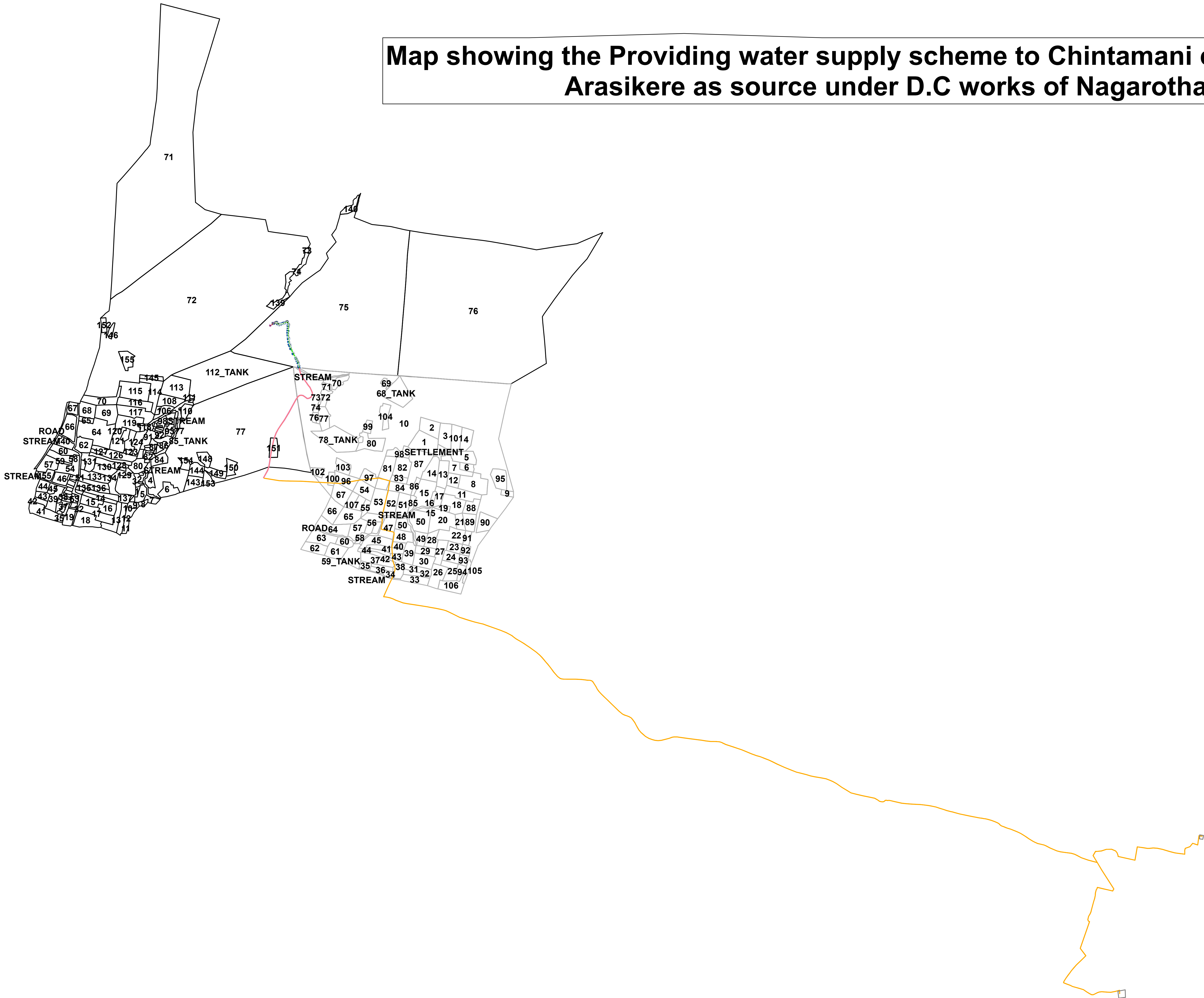


Map showing the Providing water supply scheme to Chintamani city with Bhakthrahalli and Arasikere as source under D.C works of Nagarothana -III grants.
