

### Penalty for Violation

Penalty for violation as per Provisions of Sr.No. ii (a) Para 1.21 Chapter-1 of Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines & Clarifications)-2019. The Penalty for Violation shall be equal to NPV of forest land per hectare for each year of violation from the date of actual diversion as reported by the inspecting officer with maximum upto Five (5) times the NPV plus 12 percent simple interest till the deposit is made.

**Actual NPV of the Case i.e NPV of the forest land to be diverted = 15037.00**

**Period of violation : From 28.10.2020 To 01.08.2022 = 642** (Number of days under violation)

### Calculation for Amount of NPV for Penalty/Violation

Actual NPV of case x Period of violation i.e number of days under violation / 365 = **15037 x 642/365 = 26449.00** (It is the amount of NPV for penalty/violation for 642 days)
