
ESSENTIALITY CERTIFICATE



In compliance of the Rules 6(3)(e) of the Forest (Conversation) Rules, 2003 [as amended vide the Forest (Conversation) Amendment Rules 2014: Forest (Conversation) Second Amendment Rules 2014: and Forest (Conversation) Amendment Rules 2016] it is certified that 0.0405 hectares of Forest land proposed to be diverted in favour of the Executive Engineer, TWAD Board, Nagapattinam for drinking water supply to Public in the district falls within the jurisdiction of Kadambakudi in Magarajapuram village of Magarajapuram panchayat in Thiruvudaimraudur union. It is further certified that.

It is further certificate that,

- a) There is no Tribal settlement in the area mentioned above and so the question of identification and settlement of rights under Forest Rights Act does not arise. No consultations/ meetings of the Forest Right committees, Gramsabhas, Sub Divisional level committees and the District level committees were conducted and no annexure are enclosed.
- b) The proposal does not involve recognized right of Primitive Tribal Groups and Pre-agricultural communities and as per Geological Survey conducted in this region, the proposed site is found to be suitable for construction of collector well cum foot bridge and the proposed area required is minimum for the execution of the project.
- c) no alternative suitable non forest land is available for the construction of Collector well cum foot bridge at Kadambakudi of 135m length and 3m width in Magarajapuram RF within the jurisdiction of Magarajapuram village in Magarajapuram panchayat in Thiruvudaimaruthur union of Thanjavur District.
