In reference to the queries raised by you, I am to inform you that I have applied for seeking permission under section 2 (iii) of Forest (conservation) Act, 1980 over an area of 22.258 ha of Sabik Kissam Forest in respect of Tailangi 'A' Chromite Mines of M/s IDCOL was submitted through MoEF site. The proposal was submitted as per Circular issued by MoEF & CC vide its letter no. 11-599/2014 FC Dt: 01.04.2015. Earlier the said lease was granted forest clearance over an area of 17.483 ha forest land excluding Safety zone, vide MoEF letter No. 8-81/97-FC Dt: 08.06.2001. Now IDCOL has applied the balance Sabik Kissam Forest Land over an area of 22.258 ha including safety zone under section 2(iii) of FC Act 1980 for mining and allied activities.

1. DGPS map should be authenticated by ORSAC.

Reply: it is to submit that as per clause-C (iv) of the electronic format developed by the MoEF&CC, Geo-reference map of the forest land proposed to be diverted over 22-253 Ha. Prepared by using GPS and Total Station has been uploaded in the online portal. Further, an undertaking in respect of the DGPS survey map has also been

uploaded along with KML file.

2. Justification for locating in forest land is to be uploaded. Reply: the same has been uploaded in the online portal.

3. Environmental Clearance copy is to be uploaded Reply: the same has been uploaded in the online portal.

 M and M-2 data is to be uploaded Reply: the same has been uploaded in the online portal.

In view of the above, I request your goodself to be kind enough and consider my proposal for grant of forest clearance under section 2(iii) of the FC Act, 1980 at the earliest.
